5. NEW BUSINESS

• BIG SIOUX BIKE BRIDGE AGREEMENT

Following discussion, a motion was made by Mr. Shorma and seconded by Ms. Finzen to reinvest the \$1,500,000.00 Certificate of Deposit (CD) that matures on April 26th, 2023 with Pioneer bank, the \$1,500,000.00 will be divided into 3 separate CDs as follows.

- o General Fund CD \$500,000.00 for 6 months at 4.71%
- o General Fund CD \$500,000.00 for 12 months at 4.76%
- o Water Fund CD \$500,000.00 for 12 months at 4.76%

The CDs will be quoted by all banks again as they mature. The \$23,186.30 of interest earnings consists of \$15,457.53 General Fund Interest and \$7,728.77 Water Fund Interest and will be deposited in the General Fund Money Market Account and thew Water Fund Money Market respectively with Security National Bank.
